WIOG'S "DUA LIPA TICKET" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WIOG ("Station"), 1740 Champagne Drive, Saginaw, MI 48604 during available business hours Monday through Friday, on the Station website www.wiog.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WIOG's "Dua Lipa Ticket"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. - 3. Contest Period 1. The Contest entry period will begin at 7:00 am ET on September 22, 2021 and will run through 9:59 am ET on September 24, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
 - <u>On-Air</u>: Listen to the Station weekdays during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 877-330-9464. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Contest Period 2.** The Contest entry period will begin at **10:00 am ET on September 22, 2021** and will **run** through **5:59 am ET on September 26, 2021** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

<u>Text</u>: Send a text message with the keyword platos spelled correctly to 64636 during the Contest Period. All entries must be received by 5:59 pm ET on September 26, 2021, to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Winner Selection. On or about 11:00 am ET on September 26, 2021, Station will select two (2) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
