## WIOG'S "SAGINAW SPIRIT VIP NIGHT" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WIOG ("Station"), 1740 Champagne Drive, Saginaw, MI 48604, during available business hours Monday through Friday, on the Station website www.wiog.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WIOG's "Saginaw Spirit VIP Night" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30 days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. - 2. **Contest Period.** The Contest entry period will begin at 6:00 am ET **on October 19, 2022** and will through 11:55 pm ET **on October 23 2022** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There are two (2) ways to enter:

Online: Visit the Station's website www.wiog.com during the Contest Period, click on the "Contest" link, click on the "Saginaw Spirit VIP Night" Contest link, and complete an entry form. Station will randomly select one winner. All entries must be received by 11:55 pm ET on October 23, 2022 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be

returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

<u>Text</u>: Send a text message with the keyword "spirit" spelled correctly to 877-330-9464 during the Contest Period. All entries must be received by 11:55 PM on October 23, 2022 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting will not increase an entrant's chances of winning. Limit one (1) entry per person per day, regardless of the method of entry chosen by a listener. Each day of the Contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

- 4. **Winner Selection.** On or about 7:00 am ET on October 24, 2022, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period as of the date and time of that drawing. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

The approximate retail value ("ARV") of each prize is: SIXTY EIGHT DOLLARS (\$68).

(c) One (1) certificate to Coco Loco restaurants.

The approximate retail value ("ARV") of each prize is: FIFTY DOLLARS (\$50.00).

(d) Four (4) combo tickets to Sealife Aquarium and Legoland.

The approximate retail value ("ARV") of each prize is: ONE HUNDRED FORTY FOUR DOLLARS (\$144).

## TOTAL ARV OF ALL CONTEST PRIZES IS: Three Hundred Seventy Dollars (\$370).
