WIOG'S "BIG SCREEN FOR THE BIG GAME" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. WIOG will no longer provide prize substitutions for tickets of shows or tours that are cancelled by the artist, artist management or venue.

Winner Selection. On or about 8:00 am ET on February 5, 2024, Station will select one potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
